Emerging Market Hard Currency Debt


MacKay Shields Emerging Market Hard Currency Debt strategy (the “Strategy”) seeks to achieve income and total return by investing primarily in debt securities issued by Sovereigns, Quasi Sovereigns and opportunistically in Corporates that trade in U.S. Dollars from emerging markets offering relatively attractive current market yields after adjusting for pertinent risks. The Strategy is a total return emerging markets debt (EMD) investment strategy which seeks to outperform the EMBI¹ (hard currency) universe. The investment team employs a research-driven, relative value process focused on regional selection, country selection, sector selection, security selection and yield curve positioning while also considering the portfolio’s overall duration.



ACTIVE COUNTRY WEIGHT







The Emerging Markets Hard Currency Debt Composite includes all discretionary emerging markets hard currency debt accounts managed with similar objectives for a full month, including those accounts no longer with the firm. Accounts in the composite seek to achieve income and total return by investing primarily in debt securities issued by Sovereigns, Quasi Sovereigns and opportunistically in Corporates that trade in U.S. Dollars from emerging markets offering relatively attractive current market yields after adjusting for pertinent risks. A total return EMD investment strategy positioned to outperform the EMBI (hard currency) universe. Gross-of-fees composite performance reflects reinvestment of income and dividends and is a market-weighted average of the time-weighted return, before advisory fees, of each account for the period since inception. Net-of-fees composite performance is derived by reducing the monthly gross-of-fees composite returns by .0417%, our highest monthly fee.
